## **9/11 FIRST RESPONDERS' FUNDRAISER SLATED FOR AUGUST 19**

**KEYPORT, NJ** - On July 29, federal lawmakers defeated a bill aimed at helping sick Ground Zero workers, but that's not stopping two area businessmen from joining forces on the **9/11 First Responders' Fundraiser**. The event, which will benefit the non-profit FealGood Foundation, will take place Thursday, August 19 from 7-9 pm at Trinity Restaurant, 84 Broad Street, Keyport.

The affair is being hosted by Vin Gopal, president of the Hazlet Business Owners Association and owner of the Monitor Newspapers, and Peter Grandich, founder of Trinity Financial Sports & Entertainment Management Co. and Grandich Publications.

"This is a non-partisan, non-political event to raise money for the brave men and women suffering devastating health problems from their heroism on September 11th, 2001," says Peter Grandich. "Seventy percent of those who came to America's aid at Ground Zero are now sick or have died from their 9/11 illnesses, and even though Congress has yet to pass a bill to help them, we must--as Americans--come to their aid."

Vin Gopal echoed the sentiment. "We simply cannot let the 9/11 community take a back seat to political bickering. This is not a Republican or Democrat issue. This is an American issue."

Gopal is a recognized Democrat and Grandich a well-known conservative Republican. Yet, the two put their political views aside when it comes to helping the 9/11 first responders.

“People’s lives are at stake,” says John Feal, president of the FealGood Foundation. “I applaud people like Peter and Vin who are diametrically opposed politically, yet they come together to aid dying first responders. It’s a crime that Congress can’t do the same.”

The non-partisan nature of the event is further highlighted by the officials who will be honored at the event. The FealGood Foundation will recognize three elected officials who have been ardent supporters of H.R.847, 9/11 Health & Compensation Act:
